Good and bad spirituality in business and economics today

Spirituality is flourishing in the world of multinational corporations. Companies compete in storytelling on 'spiritual paths'. This phenomenon has positive, but also negative aspects. In his lecture, Professor Bruni will discuss the instrumental use and abuse of spiritual language within companies. Biblical humanism will offer insights for such a critical analysis.

Prof. Dr. Luigino Bruni, Professor in Political Economy at Lumsa University in Rome, is known for his writings and lectures on economics, philosophy and theology, including *The Wound and the Blessing* (New City Press 2012). With Stefano Zamagni he authored *Civil Economy* (Agenda 2016). *The Spirit of the Market* is forthcoming (Oxford University Press 2018). His books have been translated in several languages, including in Dutch, such as (with Alessandra Smerilli) *De ongekende kant van de economie* (2015).

Responses will be given by two experts in the field of economics and ethics.

Eefje de Gelder MA MSc is coordinator of the research program 'Morality and Markets' at the Vrije Universiteit Amsterdam. She studied International Economics and Christianity & Society at Tilburg University and is preparing a PhD thesis on the question: 'How does the increased popularity of fair trade products affect the producers?'

Prof. Dr. Johan Graafland is Professor in Economics, Business and Ethics at Tilburg University. He studied economics at Erasmus University and theology at Utrecht University. He is affiliated to the department of Economics and the department of Philosophy at Tilburg University and member of Tilburg Sustainability Center. Currently, he is involved in the Templeton Project 'What good markets are good for' (www.moralmarkets.org).


